CONSENT JUDGMENT

This suit was filed on 18/7/2018 by the Claimant, under the "Undefended List Procedure". After pleadings was filed and exchanged, the parties prayed for an out of court settlement and consequent upon this application, granted by the court, the parties through their counsel are praying this court to enter the Terms filed on 6/1/2020 be and as Consent Judgment of the parties.

Having carefully considered the said Terms of Settlement stating clearly the intention of the parties, I shall allow it accordingly, the said Terms of Settlement entered into by the parties and filed on 6/1/2020 be and is hereby entered as the Consent Judgment of the parties in this Suit. I so order.

TERMS OF SETTLEMENT

WHEREAS dispute had been declared between TRANSATLANTIC LOGISTIC SERVICES LTD and MERCY CORPS NIGERIA (hereinafter referred to as "the parties")

AND WHEREAS the dispute had been filed before the FCT High Court sitting at Jabi in above suit.

AND WHEREAS the parties through their Solicitors had dialoguedconsulted and resolved to amicably settle the dispute between them.

IT IS HEREBY RESOLVE AND AGREED that in the spirit of out of court settlement by both parties and in further consideration of understanding reached between the parties.

1. That out of the Claimant's claim of ₦4,977,406.00 (Four Million, Nine Hundred and Seventy Seven Thousand, Four Hundred and Six Naira),~~₦400,000.00~~ (Four Hundred Thousand Naira) be removed.
2. That the Defendant will pay the Claimant the sum of ₦4,577,406.00 (Four Million Five Hundred and Seven Thousand, Four Hundred and Six Naira) being the unpaid balance.
3. That these terms represent the agreement reached between the parties and represent the full and final payments and issues between the parties.
4. Parties are to bear their costs.
5. These Terms be entered as Consent Judgment ofthis Hon. Court.
