CONSENT JUDGMENT

The parties in this suit have filed a Memorandum of Settlement on 22nd February 2021 which provides thus:

The parties to this suit have decided to settle their matter in this Court based on the terms herein stated;

WHEREAS;

The Petitioner seeks the following reliefs:

1. **A DECREE** of dissolution of the marriage between the Petitioner and the Respondent contracted on the 21st day of February, 2017 on the ground that the marriage has broken down irretrievably.

2. **AN ORDER** allowing the petitioner and the Respondent to bear their responsibilities themselves.
3. **AN ORDER** restraining the Respondent from interfering with, dealing adversely with the Petitioner in anyway whatsoever that may infringe or impugn on the compliance with the Orders of this Honourable Court in anyway whatsoever.
4. **AND FOR SUCH FURTHER** Orders as the Court may deem fit to make in this circumstance.

NOW THESE TERMS OF SETTLEMENT WITNESSETH AS FOLLOWS:

1. **DISSOLUTION:**

The parties to this suit brought by the Petitioner have agreed for a decree of Dissolution of Marriage between the **petitioner** and the **Respondent** contracted on the 21st February, 2017 on the ground that the marriage has broken down irretrievably.

2. **MAINTENANCE:**

(a). The **Petitioner** shall not claim any form of maintenance from the **Respondent** and shall move on with her life and maintain herself personally without liability or obligation to the **Respondent** whatsoever.

(b). The Respondent shall also not claim any form of maintenance from the **Petitioner** and shall also move on with his life and maintain himself personally without liability or obligation to the **Petitioner** whatsoever.

The parties to this Memorandum of Settlement hereby specifically agree to be bound by the Terms of this Settlement as to all particulars hereof and hereby reaffirm the acknowledgments and representations as set forth in this Agreement.

Therefore, the parties having duly executed and adopted the said Memorandum of Settlement, same is hereby entered as the Judgment of this Court in this petition.

Accordingly, I hereby make an Order Nisi dissolving the marriage between the Petitioner MARIA ILINCA TROFIN and the Respondent

MOHAMAD MAHFOUZ RACHID contracted at the Federal Marriage Registry Abuja Nigeria on the 21st day of February 2017. The Decree shall become absolute if nothing intervenes within a period of three months from the date thereof.
