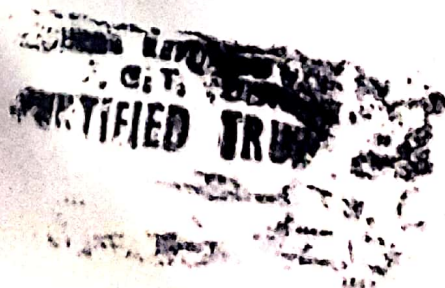

CONSENT OF JUDGMENT

This is a Claim for liquidated money demand which was initiated under the Federal Capital Territory Practice Directions on small Claims Court 2022. The Application for plaint is dated 1st December 2021 3 and filed on same date.



The small Claims complaint form (SCA2) disclosed that the defendant took a loan of N200,000.00 (Two Hundred Thousand Naira) with a monthly 10% interest on the 3rd July 2017, the defendant have however failed to pay the loan, the capital sum and interest despite several demands.

The defendant upon service of Form SCA responded by filing form SCA5 that is Small Claims form of Admission, defence and Counter-Claim wherein she admitted borrowing the sum of N200,000.00 (Two Hundred Thousand Naira) from the Claimant, she however denied agreeing to a 10% monthly interest, according to her, the consideration for the loan is N20,000 (Twenty Thousand Naira), the 10% interest she stated was introduced unilaterally by the Claimant when she could not pay the loan.

On the 17th January 2024, learned counsel to the defendant Chidi Odo informed the court that the defendant want to explore an alternative means of settlement, Mr E.C oti, Counsel; to the Claimant agreed subsequently, matter was adjourned for Report of Settlement.

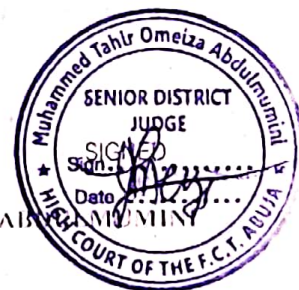
