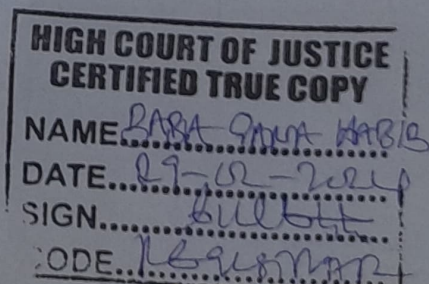

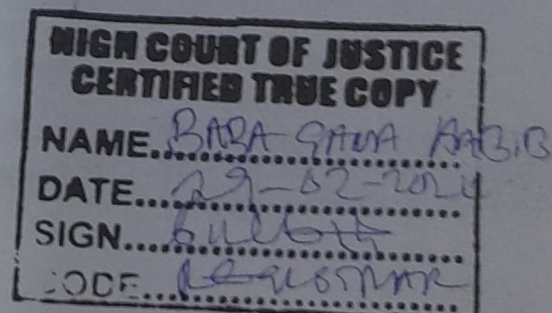

RULING

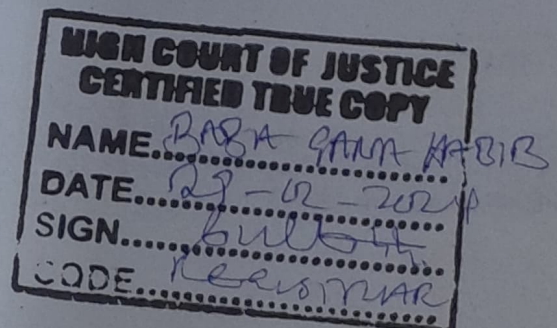
