## JUDGMENT

This suit was commenced under the Small claims procedure wherein the claimant claims the sum of N486, 887.43 against the defendant as contained in forms SCA 3A and 3B served on the defendant. By the provision of Article 7 paragraph 2 of the Small Claims Practice Direction, 2022, a defendant upon being served with forms SCA 3A and 3B is expected to within 7 days file in response as defence Forms SCA 5 and SCA 5A stating reasons why judgment should not be entered against him. The originating process in the suit was served on the defendant on the 8/11/2023 however, the defendant failed to file any counter process in opposition to the sum claimed by the claimant

The position of the law is that where averments contained in an affidavit are not challenged by way of a counter affidavit or reply affidavit, such averments are deemed admitted by the party against whom they are averred and the court is at liberty to take same as the true state of facts. See CHIJIOKE AGU v. OKPOKO (2009) LPELR-8286(CA)

The position of the law also remains settled that a party who has been given the opportunity to defend an action but failed to do so cannot

perusing the affidavit of the claimant in form SCA 3B and the letter of demand attached to same, in the absence of any response from the defendant, this court is satisfied that the defendant has no defence to the sum claimed

Consequently, this court hereby finds affirmation in the fact that the defendant is indebted to the claimant. The defendant is hereby ordered to pay to the claimant the sum of N486, 887.43 (Four Hundred and Eighty-Six Thousand, Eight Hundred and Eighty-Seven Naira Forty-Three Kobo Only 1

Kobo Only) being the debt owed.
