RULING
(DELIVERED BY HONOURABLE JUSTICE S. B. BELGORE)

Upon reading the affidavit of fact dated and filed on **07/02/2025**; upon the admission of the judgment debtor that the sum of **N140,000,000 (One Hundred and Forty Million Naira Only)** is due to the Judgment Creditor; and the 1st Garnishee having no objection and having attached the said judgment sum by virtue of the order of this Court made on the **22/07/2022**, over two years ago, it is the finding of this Court that the **Terms of Settlement** annexed as **“Exhibit A”** shall bind the parties and the 1st Garnishee shall give effect to same.

In view of my holdings above, the inevitable and logical conclusion this Court would reach is that the order nisi made on the 22/07/2022 should be made absolute against the 1st Garnishee, that is, First Bank Nigeria Plc. And I so do.

It is therefore ordered as follows for purposes of clarity:

1. **AN ORDER** is hereby made declaring that the Garnishee Order Nisi made on the 22/07/2022 attaching the sum of **N140,000,000 (One Hundred and Forty Million Naira Only)** in the custody of the 1st Garnishee, First Bank of Nigeria Plc., being the judgment sum obtained against the Judgment debtor by virtue of the judgment of this Court between **Ojukwu Chikaosolu Vs. All Progressives Congress** in **Suit No: FCT/HC/BW/CV/83/2022**; and by settlement reached in Supreme Court of Nigeria **Appeal No: SC/CV/870/2023** is hereby made absolute against the 1st Garnishee.
2. The 1st Garnishee, First Bank of Nigeria Plc., is hereby ordered to pay the said judgment sum of **N140,000,000 (One Hundred and Forty Million Naira Only)** in its custody to the Judgment Creditor's account with Account name: **Ojukwu Chikaosolu & Co.**, Account number: **0125761642** WEMA Bank Plc. FORTHWITH.
3. That all other Garnishees other than the 1st Garnishees are hereby discharged.
4. Parties to bear their respective cost.
